

## 1 Overall quality at a glance (i)

The following experimental techniques were used to determine the structure: X-RAY DIFFRACTION

The reported resolution of this entry is 2.50 Å.

A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions <=5%

# 2 Entry composition (i)





# 3 Residue-property plots (i)

These plots are drawn for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic for a chain summarises the proportions of the various outlier classes displayed in the second graphic. The second graphic shows the sequence view annotated by issues in geometry. Residues are color-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outlier are shown as a green connector. Residues present in the sample, but not in the model, are shown in grey.







• Molecule 2: GLUTACONATE COENZYME A-TRANSFERASE

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand. A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a maintenain group or atoms of a sidechain that are expected to be planar.

### 5.2 Too-close contacts (i)
