1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

X-RAY DIFFRACTION

The reported resolution of this entry is 1.30 Å.

Xtrriage's analysis on translational NCS is as follows: *The largest off-origin peak in the Patterson function is 6.14% of the height of the origin peak. No significant pseudotranslation is detected.*
